This privacy notice applies to confidential information provided to Manchester Capital Management ("Manchester Capital Management" or "MCM") and the affiliated family of investment funds for which Manchester Capital Management serves as general partner.

WHY?	Financial companies choose how they share your personal information. Federal law gives
